

Rendezvous 2017 is now history! And, boy did the Peninsula Chapter make a great showing! Here are the highlights.

- One exciting event was surviving I-90 along the lake to just get there.
 The lanes get combined and shoved sideways with no lane markings – freeform driving at its best. Add a couple of semis and some fourwheelers and you get a real show. But everyone made it safely to the other side.
- Our Director Dave Seibel did a yeoman's job of managing all the facilities during the duration of Rendezvous. Dave made sure the various buildings were open for business in the mornings and secured them for the evenings.
- Sawyer Tony Karniss put on a first ever Women Only Crosscut Saw session. We had about 30 attendees all learning how to saw without any overarching inputs from the guys!
- I coordinated FA/CPR sessions where we managed to get 28 folks certified.
- The used tack sale netted over \$7k for BCHW. There were some tremendously good buys.

- Judy Sage was on the Chapter Display judging committee. She reports that Tahoma Chapter won first, Lewis County second, and Grays Harbor third. All the displays were interesting, colorful and fun to see.
- During the Director's meeting we supported the ratification of the Mount Olympus chapter as the newest chapter of BCHW. Mt. Olympus covers the west end of the Olympic Peninsula. This was exciting and very rewarding as we have continuously encouraged and supported the formation of a west end chapter.
- (Thanks to Tom!) It was announced that BCHW has received authorization to manage our own sawyer program. Our proposal packet is now used as the preferred model nationally for other volunteer groups to use when applying for program authorization.
- Saturday evening's dinner, auction, and dance were a success.
 Debbie Dosey and her crew won the Best Table Decoration for the BCHW Mission Statement Award. It consisted of a standard USFS stock bridge

- spanning between our two tables, made by Delman Sage, who also supplied the packstring that was bringing in more bridge decking and equipment. The table display was rounded out with wooden chargers made by Dan Dosey, several photos and very nice centerpieces donated by Sophies Florist in Sequim. It was a total "hands down" win as no other chapter came even close to our decorative display. Kris Phillips' horse whiney could be heard all across the room as events unfurled.
- I picked up crosscut saws needing refurbishing and we were invited to help Whatcom Chapter install a bridge later in the season.
- Trail Manager Tim Van Beek of the Washington Trails Association sat with us as our guest. He wants to use our Share the Trails 3S materials for when they conduct their youth encounters this season.
- The general meeting went well for us as Delman Sage won the Men's division Best Trailer Backing competition, and his daughter, Anna, won the Women's division Best Trailer Backing competition, There were

- tears in our eyes as Judy Sage was recognized with the prestigious BCHW Desk Jockey Award for all her tireless efforts compiling our volunteer hours records. And, Larry Baysinger, past member of the Peninsula Chapter and new President of the Mt. Olympus Chapter, received the **BCHW Lifetime** Achievement award. Take Note - Lake Crescent Highway Rehab

Along with the tourist, those wishing to haul stock to the West will want to check ahead and plan accordingly. The contract for rehabilitation of 12 miles of the Lake Crescent Highway 101 and 4 miles of East Beach Rd has been awarded to Strider Construction Co, Inc. of Bellingham, WA. The

\$27.5 million project will address long-term safety and maintenance concerns and cause delays over a three-year period.

Here is a synopsis of what to expect for 2017:

April – Late May ½ Hr delays during working hours, short after hour delays for one lane traffic. Limited 4 Hr delays 9A-1P w/2wk notice.

Memorial - Labor Day ½ Hr delays/working hours, short after hour delays for one lane traffic. Early Sept – Mid Nov ½ Hr delays/working hours, short after hour delays for one lane traffic. Limited 4 Hr delays 9A-1P & 6 Hr delays 10P-4A

w/2wk notice.

No work anticipated.
March 2018 & 2019 only

Extensive work is being done and the trail will most likely not be open to anyone at times. Trail Projects Coordinator Report by Tom Mix

March 9, 2017 Work Parties Held Miller Peninsula - brushing of the east side trail loop continues. 12 trail crafters made significant progress building tread and pulling pesky stumps at the PAE road intersection. Del removed a root wad partially blocking the east side trail loop near the north gate. The east side trail loop is now ready for the field mower event. The place was busy with hikers and bikers passing our work site all day long. They all thanked us for doing what we do! Signage: WSP management is looking for a vendor to fabricate the intersection signs. The Tribe has agreed to make and install signs welcoming users to enjoy and respect their lands. There will be a Work Party March 11 to finish tread construction near the PAE road intersection.

Little River trail – we were called in to remove a rather large downed fir about 3 minutes hike down trail from that fantastic foot log complex we installed a few seasons ago. 6 of us, along with 3 stock, removed the 58 inch tree from the trail. There remains about 80 feet of tree uphill from the trail. The tree was about 670 years old at the trail, probably an additional 80 to 100 years old at the butt. We really lucked-out as we did not have to deal with much end bind.

Mt Walker – Mike and his crew cleared the first part of the trail and have a return trip scheduled. Lower Gray Wolf – Finished work for the winter and fall season. Logouts, tread repair, brushing. Another scouting hike is due to the end of trail ~ 4.0 mile.

Lower Quilcene - Scouting hike found enough work for almost all of the fall months. It all starts at about 3 miles from lower trailhead to the 4.5 mile point. The work site location makes for long hikes both ways. Logouts, watercrossing repair, tread damage,

drainage damage is what we do. Lower Big Quilcene –The trail is closed to stock above Bark Shanty due to a wash out that will require a long reroute of about a 1000 feet or more, with switchbacks on both ends. No time set to start, FS still thinking about it. We walked a route and found marking tape set from a walk-a-about done years ago when FS blasted a rock face instead of the reroute.

Youth engagement – We have agreed to present our Trail Safety 3S program instruction to 2 youth groups. First will be a group of about 25 to 30 youth constructing trail on the Miller system starting at Burling Road trailhead. Later in the season we will do the same for an Eagle Scout project on the Miller system where they will be constructing the Alder Hollow trail.

BCHW Saw program – Tony Karniss and I have assembled the BCHW proposal packet to continue our ability to train and evaluate our sawyers statewide. The new USFS National Saw Policy has just been adopted. The BCHW program proposal has received Region 6 and National Saw Program approvals. Our program proposal packet is being offered nationally by the USFS for others to replicate to obtain their

program authorizations. Your First Aid and CPR must be current and remain so during the life of your certification. We will be updating our BCHW sawyer program to be in compliance. All existing sawyer certifications remain in effect. The BCHW Sawyer web page will be updated soon. Contact Tom Mix or Del Sage should you need to get certified or recertified for chain or cross cut saw work.



John Wayne Trail Resolution

Those who are familiar with the topography of the eastern side of Washington State may already know how important the John Way Trail (JW Trail) is. It is a "300-mile long stretch of former railway rail bed that extends from the western slopes of the Cascade Mountains to the Idaho border and is the longest rail trail in the United States." This quote is taken from the

Clallam County Board of Commissioners Resolution 32, 2017 supporting the preservation, maintenance, and improvement of the John Wayne Pioneering Trail. In fact, the Clallam County Commissioners fully adopted the Resolution as written by BCHW and it passed unanimously. The Resolution further


The Resolution further describes the Trail. It is

owned by Washington State Parks and WA Dept. of Natural Resources. It was designated as a National Recreational Trail by the federal government in 2002. Cyclists, hikers, horse riders, and the JW Pioneer Wagons and Riders Assoc, use it for their Annual "Ride Across Washington" event. The ODT is connected to the JW Trail via the Sound to Olympics Trail, the Kingston Ferry, the Burke Gilman Trail, and the Snoqualmie Valley Trail. This makes it truly an across the State trail. The Resolution and need for such has come about due to the recent discussion of closing a portion of the JW Trail east of the Columbia

River. This is because some adjacent landowners brought forward concerns about ongoing maintenance of the trail.

It becomes apparent

ongoing maintenance of the trail. It becomes apparent through this Resolution that BCHW and our County agree to the importance of recreational trails throughout Washington. Shared cooperation for the maintenance and expansion of recreational trails often falls on the multiple agencies and the volunteer organizations, such as BCHW and Chapters, to advocate and work towards keeping our trails open to all citizens and user groups. Be sure to thank your County Commissioners for taking this stand.

Jan Whitlow, PTC representative gave us a few updates:

- The new bridge at Discovery Bay will have a ribbon cutting ceremony in mid-April. Check their website for updates.
- Parts of the Adventure Trail will be closed because of logging. The areas will be well marked. Check the ODT website for updates or their Facebook page.
- The Spruce Railroad tunnels are being cleared out, one will be done later this year, and the other will likely go to next year due to technical problems.
 - The needs for trail adopters and trail maintenance work were discussed. A possible horse trailer parking near Mary Clark Rd in the next 3 years is in the preliminary stage.
- As Vice President for the West Clallam section of the trail I am learning as I go. I'll be looking for west end adopters.
