

BCHW Public Lands USFS Volunteer Service Agreement Finalized

B CHW and Pacific NW Region 6 of the US Forest Service finalized a Volunteer Service Agreement OF301a (VSA) on April 20, 2021 The agreement will cover our volunteer work in all of Washington's National Forests and will alleviate the need to complete OF301a VSA documentation at each Forest Service district that we work in. In the future, these documents will be reviewed annually with Pacific NW Region 6 and BCHW to address any changes. (Form OF301b will still need to be signed by volunteers at job sites.)

Each of Washington's National Forests has reviewed and has access to this agreement, including the supporting Risk Analysis'/Job Hazard Analysis' documentation. BCHW members need to become familiar with the agreement and the supporting documents and be able to refer to it when talking with your Forest Service Districts. Any questions that the Forest Service Districts have should be referred back to their Forest Supervisor office. The full VSA and supporting documentation is posted on the BCHW website. www.bchw.org. BCHW members working on Forest Service properties need to take the time to review and familiarize themselves with this important documentation. Back Country Horsemen of Washington must contact and is responsible for fully coordinating with the Forest Service liaison for each district to obtain approval for work activity, to schedule actual workdays, as well as to make arrangements to ensure that work is accomplished to the Forest Service safety, COVID phasing and technical standards. Conducting unauthorized work could result in the termination of this agreement. Communication with local Forest Service Districts remains critical.

US Forest Service Region 6 is beginning to roll out a program that will be used to streamline communications and planning when coordinating with volunteer organizations like BCHW. They are moving toward a model that will assign a single point of contact at each National Forest in Washington, to work with our organization for future project planning purposes. The vision is that BCHW will also be able to name a BCHW member as a single point of contact to work with each Forest for future project planning purposes. This model is already being implemented in the Olympic National Forest with BCHW member Mitzi Schindele taking a role that supports the BCHW chapters that are active in that National Forest. Mitzi will regularly meet with Olympic Forest Service Ranger Nicole Lagioia, Natural Resource-Recreation. The Forest Service goal for this program is to reduce redundancy and to support project prioritization.

BCHW will look to its chapters to identify future projects or areas of concern for stock access. The chapters would then elevate those lists to BCHW's designated National Forest contact. That BCHW representative will be meeting regularly with the designated Forest Service contact. This is a developing program and communication about it is still taking place throughout Region 6. At BCHW we will be looking at this as a way to strengthen communication among chapters that work together and that work in the same forests. BCHW will want to identify a member to be the single point of contact to work/communicate with several chapters. As this single point of contact program rolls out it will still be necessary for chapters to work closely with their local districts, those relationships continue to be very important.

Trailhead Camping

drafted this article in my head as I had a great ride on the Bureau of Land Management (BLM) Escure property. What a wonderful way to spend a holiday. It also got me thinking about what we need to do for trailhead camping with our horses.

Trailhead camping is not difficult and does not take a great deal of equipment. You can leave the big rigs at home and go very light. Sleep in the back of the horse trailer, use a sun shower, and cook one-pot meals on a gas stove. I believe in spending the time in the saddle. This greatly expands the locations you can ride.

A bigger factor is how to care for the horse in camp. At Escure, we have ten corrals and highlines for six horses. There are no trees for highlining. Some people use temporary electric fences if there is room, and it does not interfere with other campers. The last resort for me is to tie to the trailer. It is the least comfortable for the horses. We never tie to a tree for long periods of time because of damage to the trees. Whatever we do, please train the horse at home first.

A major factor is the removal of manure and old, uneaten hay. The first choice, for a short stay, is to put it in the back of the trailer and haul it home. Another is to adequately scatter it in an open field. This can be very limited in heavily used campgrounds. Feeding with a hay bag of some sort and keeping the hay and manure cleaned up will greatly reduce the wasted hay.

The thing we never do is leave the manure and hay in the corral, or highline area. This is what we found at Escure. With eight brand new corrals, someone left four of them full of hay and manure. It took over six wheel barrel loads to clean them out. There is no excuse for this. BCH built a manure bunker, donated a wheel barrel and manure fork. It can only be chalked up to being inconsiderate, lazy, and selfish. Do these people want to come into a camp and find this mess?

The same holds true at day-use trailheads. Pick up the manure. Put it in the trailer. If someone does not carry a manure fork, then buy one.

You may be offended by the content or tone taken here but I do not apologize. Many people work extremely hard to keep our trails open for responsible horsemen. People who do not use common sense should be called out. If you know someone like this, please educate them before we all lose the privilege to ride on public land. \searrow

Meeting Minutes BCHW Special Board of Directors' Meeting March 20, 2021, Held Virtual through Zoom

eeting was called to order by President, Jason Ridlon. Roll Call attendance was taken and a quorum was present. The agenda was adopted. Items noted on the agenda were posted for Directors to read prior to the meeting on the BCHW Secure site.

A few things to note were:

The Executive Advisory Committee (EAC) 2020 Action report (Jason Ridlon) indicated the importance of Chapter Directors attendance at BOD meetings. He asked EAC advice regarding attendance concerns regarding Inland Empire Chapter. They recommended he send a letter to the Chapter encouraging action by the Chapter leadership on two issues: #1 attending BCHW BOD meetings and #2 providing the BCHW Treasurer with monthly bank statements. There was discussion regarding Chapter health and ways to reach out to the Chapter membership. Jason did ask if the attendance concern continues for the Directors to take action.

Treasurer Report (Teri Starke) provided updates on the budget versus actuals and answered questions. We have been blessed to have had some sizable donations made to BCHW, which has helped since we were not able to have some of our larger fundraising events due to the pandemic. Every year 3 BCHW Chapters are audited. This year they will be Wenas, Whatcom, and Inland Empire. Teri reminded Directors that Chapters are to send in their bank statements each month.

Nomination Committee (Jason Ridlon/Ken Carmichael) reminded the BOD that the majority of the BCHW head leadership (President, Vice President, Secretary, and Treasurer) will all be stepping down at the end of 2021. The committee members are Ken Carmichael, Lori Lennox, Dave Jackson, and Barb Thomas. If you are interested in running for one of the positions, please contact these individuals. If you know of someone who is outside the organization who may be a good fit, please have them contact one of the committee members. Please post on your Facebook, social media, Chapter newsletters that these positions are needing applicants. Legislative Committee (Mitzi Schindele) provided updates regarding the eBike Bill. Contact Kathy Young and/or Mitzi if you have questions about how the eBike committee will continue. To stay in tune, check out the legislative web page on the BCHW website.

Grants Committee (Darrell Wallace) indicated that our current set of grants will wrap up on October 31, 2021. The committee is currently reaching out to grant liaisons to ensure allocations and match requirements can be met due to the impact of the pandemic.

In the fall of 2020, BCHW submitted proposals for 4 RTP (Recreational Trails Program) grants. The preliminary ranks were as followed: #6 of 9 -Tread Lightly for Public Recreation – Education Project (\$17,410 with \$96,120 match) #3 of 49 BCHW – Rehabilitating Olympic Peninsula Trails (\$82,486 with \$207,974 match), #5 of 49 BCHW – Reopening Threatened National Forest Trails (\$117,600 with \$237,200 match), #8 of 49 BCHW – Maintaining Endangered Trails (\$57,817 with \$111, 500 match) We will find out more about finalized funding in the late spring. If awarded and funded, these grants will begin in November 2021 and complete by November 2023. We are excited that these grants scored so well.

Public Lands Committee (Kathy Young) updated the board about the work to regionalize BCHW representation across the state. As of the date of there is no one person per region that our land managers can contact. The Olympic National Forest has requested BCHW designate a single point of contact for planning and prioritization of projects across the forest. The opportunity to regionalize will be to incorporate BCHW and stock access priorities into the broad strategic planning of projects across the forest.

Work continues to have a single volunteer agreement with the National Forest Region 6. It is important to familiarize Chapters with the agreement. There will be specific authorizations for projects that will still be required to be obtained at the Forest Service District level to perform work under the agreement. For any questions, contact members of the Public Lands Committee.

Officers and Committee Reports - reports were posted

EAC 2020 Action Report – Jason Ridlon

Various topics were reviewed in the report. Jen Bond (BCHW Grants and Event Admin) our independent contractor had a 6 month review. There is still evaluation work being done to find a replacement for groupspaces. Discussion about another independent contractor being advertised for Sponsorships. Inland Empire Chapter leadership were contacted about the importance of attendance at BOD meetings.

Motion made by Ken Carmichael (Ponderosa) seconded by Dave Sunde (Okanogan) to accept the EAC decision to have Teri Starke contact the WA state gambling commission regarding RRR request for a gambling license. The commission requested a change to the Articles of Incorporation. The 4th approved version of the BCHW Articles of Incorporation are posted on the Secure site. Motion carried.

Reviewed BCHW Directory and discussed how many open leadership positions including Chapter Director and Alternates. These positions are vital to the health of our organization. There was a document posted regarding the duties of the BCHW Chapter Director. Directors/alternates should be aware of the duties and ask for training if needed. Past directors should help new directors to ensure a successful transition. Discussed the fiduciary responsibility of the BCHW Chapter Director to the state.

Grants – Jen Bond

Reviewed a PowerPoint with information on what things that are not so obvious that RTP grants fund: Trailhead News, $\neg æ$ of our BCHW liability insurance, administration of the grants, training costs (such as sawyer certifications, first aid). There is a project template available on the Secure site for Chapter leadership to use to send requests for assistance to Jen. Directors were encouraged to reach out to their Chapters to ask if there is a need that Jen could help with.

Special thanks given by Darrell Wallace to Tina Short for her effort of submitting 2 of grants in the fall of 2020. If the below are awarded, Jen will take over management of the grants. The proposals for 4 RTP (Recreational Trails Program) grants. The preliminary ranks were as followed: #6 of 9 -Tread Lightly for Public Recreation – Education Project (\$17,410 with \$96,120 match)

#3 of 49 BCHW – Rehabilitating Olympic Peninsula Trails (\$82,486 with \$207,974 match), #5 of 49 BCHW – Reopening Threatened National Forest Trails (\$117,600 with \$237,200 match), #8 of 49 BCHW – Maintaining Endangered Trails (\$57,817 with \$111, 500 match) We will find out more about finalized funding in the late spring. If awarded and funded, these grants will begin November 2021 and complete by November 2023.

Rendezvous 2022 - Teri Starke/Jen Bond

Teri is working to transition past Rendezvous planning information to Jen Bond (BCHW Events Admin). Clinicians are being identified. The dates set for 2022 are the weekend of March 18 through 20th. Starting to identify vendors. The layout will be similar to past years.

There will be a special BOD meeting (September 17 Friday) prior to the regular 3rd Quarter BOD meeting. This special BOD meeting will be focused on the BCHW Re-imagined proposal. It will be in person only.

Centralized Accounting Proposal – Teri Starke

A motion was made by Ken Carmichael (Ponderosa) and seconded by Scott Lee to amend the original motion from the April 2021 Special BOD meeting Bob Hoyle (Buckhorn Range) and seconded by Lori Lennox (Grays Harbor) to "proceed with centralized accounting of chapters". Discussion followed. Motion carried. 1 opposed vote and 2 abstained.

The motion as amended from Ken Carmichael (Ponderosa) and seconded by Scott Lee (Cascade Horse Club) was ,"move that BCHW adopt a Centralized Accounting System that will include:

- All chapter funds be kept in one or more bank or credit union accounts with sub accounts for each chapter managed by BCHW.
- BCHW is responsible for managing all funds for maximum return on investment at no risk.
- Chapters retain the authority to determine how chapter funds are spent within the guidelines of BCHW and 501C3 regulations and policies.
- Other chapters and BCHW cannot spend money from a chapter account.
- BCHW provides the chapter with monthly accounting reports showing chapter expenses, income and account balances.
- Chapter expenditures be processed as follows:
 - Funds transferred between BCHW, and the chapters is done electronically by BCHW
 - Chapter checks are written by BCHW, or an accounting firm, at the written request of the chapter
 - Chapters have limited credit cards issued by BCHW for some chapter expenses
- Chapter income may be deposited at a local branch or sent to BCHW for deposit in the chapter subaccount.
- BCHW accounting staff completes the Chart of Accounts based on the income and expense reports from the chapters.

- BCHW maintains an accounting staff, and hired accounting firm, sufficient to process all accounting transactions on a timely and accurate basis.
- BCHW Treasurer, and staff, provides accounting instructions to Chapter Treasurers with required attendance.
- Chapters continue to create chapter budgets and track income and expenses to ensure that chapter funds are spent according to chapter expectations and not over extended.
- Chapters must control the distribution of credit cards and request changes as appropriate with change in volunteers.
- Chapters must maintain a level of knowledge about government accounting regulations with the assistance of BCHW expertise. (e.g., resell permits, gambling, 501C3, sunshine funds, etc.)
- All chapters will participate in the Centralized Accounting System within three months of successful completion of the pilot program.

Discussion followed. Motion carried. 4 opposed votes.

A motion was made by Ken Carmichael (Ponderosa) and seconded by Louise Caywood (Pierce County) to "open one checking account and 2 savings accounts at Washington State Employees Credit union in Ellensburg, WA to centralize BCHW accounting. Teri Starke and Dana Chambers will be the signers on these accounts. Discussion followed. Motion carried.

New Business:

Membership Process Proposal - Dana Chambers

Dana provided a quick overview of the posted proposal that was provided on the Secure site prior to the meeting. A motion was made by Bob Iddins (Trail Dusters) and seconded by Ken Carmichael (Ponderosa) to ,Äúmove to adopt the new process for handling paper membership applications as presented and written by the State Membership Chair. This procedure will be codified by standing rule. Discussion followed. Motion carried. 1 opposed vote. The new process will proceed forward starting July 2021.

Dissolving of Yakima Valley Chapter – Ken Carmichael

Mileage reimbursements will be at the State of Washington annual published charity rate or actual fuel expense. You must attach the documents required in Standing Rule ,"Taxable Income Payments to Volunteers" to each reimbursement request. You cannot take a tax deduction for mileage at any rate when you receive reimbursement by BCHW.

If a grant will ultimately reimburse this expense, make sure you note the grant name and number in the explanation section. Grant Administrators have the reimbursement form edited for their specific grant numbers.
